- 2. You must always follow the instructions of the marshals and abide by their decisions.
- **3.** Goggles to be worn as instructed by the marshalling staff.
- 4. GOGGLES ARE NEVER TO BE REMOVED FOR ANY REASON DURING GAME PLAY BLINDNESS COULD RESULT!
- **5.** Never fire anything from your paintball marker other than the paintballs provided by Mega Paintball.
- 6. Do **NOT** shoot your marker at anyone who is not involved in the game.
- 7. Safety catches are **NOT** to be tampered with and must always remain in the safe position.
- 8. Barrel plugs are NOT to be tampered with or removed until instructed by the marshals.
- 9. Do NOT fire or prepare your marker for gameplay until instructed to do so by the marshals.
- 10. Do NOT pick paintballs off the floor, they will be dirty and will jam the marker (damage to equipment will incur a charge).
- **11.** Do **NOT** deliberately aim at the head or face and do **NOT** shoot at persons closer than 7 Meters (ask player to surrender).
- **12.** No physical contact, abusive behaviour or swearing towards other players will NOT be tolerated.
- **13.** Do **NOT** leave the game fields during play, stay within the defined boundaries no climbing trees.
- 14. Do NOT deliberately shoot at any visible wild animals please respect the countryside.
- 15. Paintballs not used at the end of the session are non-refundable due to air exposure.
- 16. I understand that for safety reasons my session could be forfeited if I break these rules.

RELEASE AND RENTAL AGREEMENT:

Although all steps are taken to ensure your safety, Mega Paintball shall not be liable for injury or damage caused through the actions of others. All property left on the premises or in the car park is at the owners risk. Mega Paintball shall not accept any responsibility for loss or damage to such items. We reserve the right to exclude any participants believed to be under the influence of drink or drugs.

I the undersigned, understand and agree to participate in Paintball entirely at my own risk, and recognise that there are such hazards as branches, trees, animal burrows, roots, uneven terrain, boundary fencing, gamezone props including cover and other trip hazards. Although our woodland is regularly maintained there is always the slim possibility of falling tree debris during an event. I note the inadvisability of wearing jewellery that may become entangled or otherwise cause injury during the event.
